Clewley from New Zealand and Ms. Madhu Singh, Senior Programme Specialist, UIL, Germany were the speakers.

The highlight of the presentation given by Ms. Liz Bowen - Clewley was as follows:

- In order to know Recognition of Prior Learning (RPL) competency should be checked.
- The terminology "being qualified varies according to the context".
- Lack of formal qualification does not mean that some one is not competent.
- The critical concepts in assessment are Purpose, Meaning, Text.
- The benefits of RPL is one can capitalise what has been learnt which will save time and resources and it gives formal assessment of previously recognised skill.

The concern shown of the presentation given by Ms. Madhu Singh is as under:

- Building national recognition of prior learning.
- Variety of approaches to the policy and legislative context.
- Difference in use of learning outcomes in the qualification or recognition.
- Considering a good recoginition of Prior Learning.
- Different approaches to governance of recognition of Prior Learning.

There is a need of institutionalising RPL to fill a gap both in formal and informal learning.
