The next public examination for conduct of Secondary and Sr. Secondary courses will be held during March-April, 2016. The Schools/Institutions eligible for Establishment of NIOS Examination Centers who wish to apply may submit the Examination Centre Application form through online by visiting NIOS website. The schedule of application will be applicable from **11th December 2015 to 10th January 2016**. The Examination Center Acceptance Application Form has to be submitted through online mode by the following process :-

- Submission of downloaded Copy of Examination Centre Acceptance Application duly signed alongwith latest photograph of the Centre Superintendent.
- Submission of hard copy of the Undertaking received from the Bank for custody of Question Paper packets.
- Enclose a copy of the Affiliation letter of the School/College by the State Board/University/AICTE.

All the documents mentioned above are required to be forwarded to the Director(Evaluation), NIOS, A-24/25, Sector-62, Noida-201309 with a copy to Regional Centre concerned. Regional Directors are hereby directed to explore and exhaust all avenues required for receipt of Examination Centre Acceptance Application Forms from reputed Schools/Degree Colleges/Engineering College to ensure free and fair conduct of NIOS Examination. It has also to be ensured that the entire process is given finality within the stipulated time limit.
