Subject: Preventive measures against spread of COVID-19 at Examination Centres -reg

Dear Centre Supdt.,

NIOS Public Examinations of March 2020 (Theory part) shall commence w.e.f. 24.3.2020 across India. Since, there is scare amongst people at large about the spread of viral infection COVID-19 and it is therefore desirable that appropriate steps are taken to ensure that there is no likelihood of spread of this.

Accordingly, and in light of the Advisory already issued by Ministry of Health and Family Welfare, the following directions are required to be issued to Centre Superintendents immediately for compliance:

- 1. The centre Supdt. must ensure that appropriate distance is maintained in the class rooms of the exam centre while making the seating arrangements.
- 2. Proper hygiene must also be ensured.
- 3. The rules of NIOS (as per Centre Supdt. Guidelines) already provide that there shall be at least two Invigilators in each room (except when the strength is less than 10).
- 4. The utilization of rooms/halls must be done in such a manner that minimum physical distance of atleast one meter is maintained. Incase, required, additional rooms may be utilized with the permission of Regional Director.
- 5. If there is shortage of room on any particular day, Laboratory/Library, Audotorium etc can also be converted and used as rooms.
- 6. The invigilation staff and other staff associated with Exam centre may be advised to cover their nose and mouth with face mask etc. during the performance of their duties.
- 7. The staff as well as examinees are permitted to carry their own sanitizers, if they desire so.

- 8. Likewise, the examinees are also permitted to use face mask if they desire so. However, none of these shall be permitted at the cost of any laxity in invigilation.
- 9. Incase any such examinees with symptoms of coughing/sneezing or fever, he/she must be seated separately and incase he/she is not carrying mask, improvised mask from tissue paper etc may be made available.
- 10. Avalaiblility of soap and adequate water supply must be ensured in toilets. The toilets must be cleaned and sanitized.

Advisory on Social Distancing Measure in view of spread of COVID-19 disease

Social distancing is a non-pharmaceutical infection prevention and control intervention implemented to avoid/decrease contact between those who are infected with a disease causing pathogen and those who are not, so as to stop or slow down the rate and extent of disease transmission in a community. This eventually leads to decrease in spread, morbidity and mortality due to the disease.

In addition to the proposed interventions, the State/UT Governments may prescribe such other measures as they consider necessary.

All these proposed interventions shall be in force till 31st of March, 2020. They will be reviewed as per the evolving situation.

The following interventions are proposed:

- Closure of all educational establishments (schools, universities etc), gyms, museums, cultural and social centres, swimming pools and theatres. Students should be advised to stay at home. Online education to be promoted.
- 2. Possibility of postponing exams may be explored. Ongoing exams to be conducted only after ensuring physical distance of one meter amongst students.
- 3. Encourage private sector organizations/employers to allow employees to work from home wherever feasible.
- 4. Meetings, as far as feasible, shall be done through video conferences. Minimize or reschedule meetings involving large number of people unless necessary.
- 5. Restaurants to ensure handwashing protocol and proper cleanliness of frequently touched surfaces. Ensure physical distancing (minimum Imetre) between tables; encourage open air seating where practical with adequate distancing.
- Keep already planned weddings to a limited gathering, postpone all non-essential social and cultural gatherings.
- Local authorities to have a dialogue with organizers of sporting events and competitions involving large gatherings and they may be advised to postpone such events.
- Local authorities to have a dialogue with opinion leaders and religious leaders to regulate mass gatherings and should ensure no overcrowding/at least one metre distance between people.

- 9. Local authorities to have meeting with traders associations and other stakeholders to regulate hours, exhibit Do's and Don'ts and take up a communication drive in market places like sabzi mandi, anaj mandi, bus depots, railway stations, post-offices etc., where essential services are provided.
 - All commercial activities must keep a distance of one meter between customers.
 Measures to reduce peak hour crowding in markets.
 - 11. Non-essential travel should be avoided. Buses, Trains and aeroplanes to maximize social distancing in public transport besides ensuring regular and proper disinfection of surfaces.
 - 12. Hospitals to follow necessary protocol related with COVID-19 management as prescribed and restrict family/friends/children visiting patients in hospitals.
 - 13. Hygiene and physical distancing has to be maintained. Shaking hands and hugging as a matter of greeting to be avoided.
 - 14. Special protective measures for delivery men/ women working in online ordering services.
 - 15. Keep communities informed consistently and constantly.
