## OFFICE ORDER - 272/12

On the recommendation of 18<sup>th</sup> Evaluation Committee Meeting held on 6<sup>th</sup> March 2012 and also recommendation by the 12<sup>th</sup> Meeting of Academic Advisory Council held on 20<sup>th</sup> April 2012, the Executive Board of NIOS in its 62<sup>nd</sup> Meeting held on 18<sup>th</sup> June 2012 approved the guidelines for bringing more transparency in evaluation system.

The approved recommendations of the committee with regard to bringing more transparency in Evaluation system are given below:-

- (a) The Answer Books, other than UFM/Mass copying, and re-evaluation and rechecking cases, may be retained for 45 days only from the date of declaration of result. In the case of UFM/Mass copying and re-checking and re-evaluation cases, the answer books be retained for 45 days from the date of declaration of the respective result.
- (b) The re-evaluation of Answer Book of Senior Secondary Examination may continue as before.
- (c) The time allowed to apply for re-evaluation may be restricted to 15 days from the date of declaration of result.
- (d) Provision may be made for applying through on-line for re- evaluation.
- (e) A processing fee of Rs.500/- be fixed for availing copy of one Answer Book.
- (f) A certificate be obtained from examiners that he/she has followed the Marking scheme strictly while Evaluating the Answer Books.

This will be implemented with effect from 18<sup>th</sup> June 2012.
