Dear Sir,

As you are aware that the Association of Indian Universities (AIU) has already accorded equivalence to the GCE 'O' & 'A' Level Examinations conducted by the University of Cambridge, Edexcel and other Boards with Grade 10 & 12 of an Indian Board respectively.

Making an amendments in the Resolution already adopted, it may now be read as:

"Minimum five passes in IGCSE/GCSE/GCE 'O' Level (in Grades A-E) including English offered by the approved British Examining Bodies is equated with Grade 10 of an Indian Board".

Further those who pass the above examination and also pass minimum 2/3 subjects at GCE 'Advanced' Level Examination from the approved British Boards their qualification can be equated with +2 state qualification of an Indian Board".


