Consequent upon the recommendations of the Academic Prospectus Committee and subsequent approval by the Competent Authority, the following is notified for examination, admission and e-services:-

- (1) Supporting Documents for date of birth proof for Secondary Course:
 In addition to the existing provision, Aadhaar card (having the details of date of birth) will also be considered as a valid document for the date of birth for admission.
- (2) Online Admission Streams 3 & 4: Submission of hard copy/print out not required

 Admission for Streams 3 & 4 will be paperless. The learner will have the facility to upload the requisite documents while seeking online Admission.
- (3) Acceptance of hard copy of Admission form / discrepancy cases under Stream-1 with online fee payment after the last date of confirmation:

 The learners who fail to send the Online admission form within the prescribed time period for confirmation of admission / discrepancy cases under Stream 1 can deposit online consolidated late Admission fee of Rs. 1500/- (One thousand five hundred) upto 25th December for April examination and upto 25th June for October Examination. The hard copy of the admission form can be deposited along with supporting documents at the concerned Regional Centre.
- (4) The Admission fee for Stream-2 admission will be accepted only through online mode: No offline admission form will be accepted under Stream – 2 on the pattern of Streams-3 & 4
- (5) Submission of Tutor Marked Assignment (TMA) marks after the last date of submission and declaration of result: In case, a learner fails to submit Tutor Marks Assignment on time at the Study Centre, such learner can submit the TMA along with fee of Rs. 1500/- per subject after the due date and declaration of result i.e. upto 15th July for April-May examination and upto 15th January for October-November examination at the concerned Regional Centre for inclusion in the result. No TMA will be accepted after the due date.
- (6) Revised date for change of subject /additional subject of Streams -1 & 2 learner:

 The revised dates would be from 1st January to 15th May for October-November examination and 1st July to 15th November for April May consider the Stream October-November

examination and 1st July to 15th November for April –May examinations. Such requests will be accepted only through online mode w.e.f. 01.07.2017.

For issuing duplicate I-card, an amount of Rs.100/- is being charged by NIOS. In case, the learner applies for duplicate I-card for the second time, an amount of Rs.500/- will be charged.

(8) Fee for Change of Examination Centre:

In extreme circumstances and unavoidable reasons, learners can apply for change of examination centres, after the finalization of examination notification and before the commencement of practical/theory Public Examinations on payment of Rs.1500/- (One thousand five hundred) with the submission of documentary evidence, at the respective Regional Centre. The Regional Centre will examine and recommend for approval of Director (Evaluation). In case of On Demand Examinations, the same fee of Rs.1500/- (One thousand five hundred) would be charged after registration for the change of ODE examination centre.

(9) E- Services

For making the system transparent and accountable, the following E-services are being initiated for effective learner support:

- (a) Issue of Duplicate Documents.
- (b) Requisition for Course Material.
- (c) Minor Correction in Name, Father's name and Mother's name
- (d) Change of Date of Birth, Name, Father's name and Mother's name
- (e) Change of Subject and Additional Subject

The above information has already been incorporated in the Prospectus 2017-18. This will be effective w.e.f. 01st May, 2017.
