8 VALIDITY OF THE BIDS

The bids shall be valid for a period of 90 days from the date of opening the financial bid.

The contract shall commence from the date of consent of the firm to the terms and conditions.

9 INTELLECTUAL PROPERTY

The functional software and the source code handed over to NIOS by successful bidder will be the intellectual property of NIOS and shall not be shared with any other person or entity by the successful bidder.

10 CONFIDENTIALTIY CLAUSE

The successful bidder will treat all the Information/data of the NIOS as confidential information/data and shall not disclose such confidential information to any third party without the express prior written consent of the NIOS. The information supplied by NIOS to successful bidder shall be considered as confidential even if the same is available in public domain.

The successful bidder shall take all reasonable care to ensure that intellectual property, privacy and confidentiality of the information/data are not compromised.

11 RIGHT OF ACCEPTANCE

The NIOS, reserves all rights to reject any bid without assigning any reason whatsoever, and does not bind itself to accept the lowest or any specific bid. The decision of the competent authority of the NIOS, in this regard shall be final and binding.

12 | EARNEST MONEY DEPOSIT (EMD)

All the bidders are required to submit EMD in the form of a bank draft in the name of the "Secretary, NIOS". The EMD of the unsuccessful bidders will be returned. The EMD of the successful bidder will either be returned or adjusted against performance security.

13 PERFORMANCE SECURITY

The successful bidder shall furnish performance security of Rs. 50,000/- in the form of Bank Guarantee in the name of the "Secretary, NIOS" from a Nationalized bank within 7 days from the date of acceptance of the tender.

The performance security shall remain valid for a period of 60 days beyond the date of completion of all contracted obligations of the service provider.

The performance security can be forfeited by order of the competent authority of the NIOS, in the event of any breach, negligence, or non-observance of any term or condition of the contract, for unsatisfactory performance, or for non-acceptance of the work order. On expiry of the

contract, such portion of the said performance security, as may be considered sufficient by the NIOS, to cover any incorrect or excess payments made on the bills to the firm shall be retained until the final audit report on the account of the firm's bill has been received and examined.

14 | PENALTY

In case of breach of any conditions of the contract and for all type of losses, the NIOS shall make deductions as per the recommendation of a Committee duly constituted by the Competent Authority of the NIOS time to time from the bills preferred by the Contractor or that may become due to the contractor under this or any other contract or from the security deposit or may be demanded from him to be paid within seven days to the credit of the NIOS.

Further a penalty of 10% of the contract value will be levied on the successful bidder for delay of every 7 days or part thereof in delivery/implementation of the QBMS.

The powers of the NIOS, under this condition shall in no way affect or prejudice the powers in certain events to terminate the contract vested in him as herein provided nor forfeiture of deposit mentioned above.

15 BREACH OF TERMS AND CONDITIONS

In case of breach of any of terms and conditions mentioned above, the Competent Authority will have the right to cancel the work order without assigning any reason thereof, and nothing will be payable by NIOS in that event and the security deposit in the form of performance Bank Guarantee shall be forfeited.

16 SUB-LETTING OF WORK

The firm shall not assign or sublet the work or any part of it to any other person or party. The tender is not transferable.

17 ARBITRATION

If any difference arises concerning this Agreement, its interpretation on the payment to be made there under, the same shall be settled by mutual consultations and negotiations. If attempts for conciliation do not yield any results within a period of 30 days, either of the parties may make a request to the other party for submission of the dispute for decision by an arbitral tribunal containing a Sole Arbitrator to be appointed by mutual consensus, the arbitration proceedings shall take place in the NIOS, A-24-25, Sector-62, NOIDA, U.P. The provisions of Arbitration and Conciliation Act, 1996 and the rules framed there under and in force shall be applicable to such proceedings.

18 LEGAL JURISDICTION

This Agreement shall be governed by and construed in accordance with the laws of India and the courts in the city of New Delhi alone shall have jurisdiction to entertain any suit, application or other proceeding arising under it.
