The sealed tender super scribed as "Tender for Disposal of Used/Unused Answer Books, Unused Question Papers and Other Waste Paper Etc." containing Technical Bid (Annexure-A) and Financial Bid (Annexure-B), duly signed and stamped should reach at this office by 28 MARCH 2025, 02:00PM. Both Bids to be sealed in separate envelopes. The tender will be opened on the same day at 03:00 PM by the duly constituted committee in the presence of representative of firms, if available.

Other conditions:

1. The firm should have a minimum turnover of Rs. 10 Lakh during the last three

financial years i.e., 2021-22, 2022-23 and 2023-24.

2. The firm should be registered under company act 2013.

3. The firm should have minimum three years experience for the disposal of waste

materials.

4. Firm/Agency will have to make all the arrangements like labour, hiring of vehicles,

weighing of material etc. at its own expenses.

5. Trade License from the State Municipal Corporation/Authority Concerned in the

name of the firm.

6. The entire waste material will be lifted and it also needs to be pulped in the paper mill

by the Firm/Agency at its own expenses. A certificate to this effect from the

concerned paper mill should be submitted in this office within 15 days of lifting of

such material.

7. The qualified Firm/Agency will have to deposit 95% of the estimated cost of items to

be lifted from this office through Bank Draft/online payment in favour of "Regional

Director NIOS" payable at Gangtok prior to lifting of the items. 100% payment

including GST will also be deposited by the Firm/Agency on same day as per the

actual weight of the material.

8. The Regional Director reserves the right to reject any quotation or all the quotations

without assigning any reason(s) thereof.

9. EMD of qualified Firm/Agency will only be released after the receipt of pulping

certificate.
