That the accredited institution had to conduct the admission and to carry out various other activities in accordance with rules and regulations and the directions issued from time to time by National Institute of Open Schooling. That the Accredited Institute should register/enroll learners for NIOS courses as per the norms and procedures of accreditation, rules and regulations and guidelines for admission laid down by NIOS, in addition to various other function to be performed by Accredited Institution.


That a show cause notice dated 09th March, 2009 was, therefore, served upon you directing you to show cause as to why the accreditation granted to you should not be cancelled and the appointment of **Mrs. Renu Prakash** be revoked as the Coordinator of the Accredited Institution.

That a reply on behalf of accredited institution and Coordinator has been received by this office on 02.04.2009. The show cause notice, and material pertaining to continuous violation of the rules and regulations and non adherence to the admission as well examination schedule by your accredited institute was placed before the Competent Authority. The Competent Authority after due deliberation of all the material placed before it has recommended suitable action for the alleged malpractice against the A.I. & Coordinator.

After critically examining the case to whom show cause notices were issued for the alleged malpractice. That the competent authority on the basis of material against you after due deliberation has decided to cancel your accreditation forthwith pursuant thereto you are not accredited to the National Institute of Open Schooling anymore and addressee no. 2 is not entitled to claim himself as the Coordinator of the Accredited Institution.

The students who have been enrolled through you but have not passed yet, are being transferred to another accredited institution at and around the same area for which separate orders will be issued. You are hereby directed that all the record concerning these students to be kept ready within 15 days of the receipt of this communication, to send it to the other A.I. Henceforth, you will neither give admission nor collect any fee etc from the candidates on behalf of National Institute of Open Schooling .
