**NOTIFICATION-25/2022**

Keeping in view the interest of OBE learners following modification has been done in OBE prospectus from Session 2022-23 onward:

- (a) **Dates of Online OBE Admission:** the OBE (Level A/B/C) Online Admission dates have been modified and learners can take admission in OBE courses from OBE portal from 1<sup>st</sup> April to 15<sup>th</sup> September from the Session 2022-23 onwards.
  - (b) **Proof of Residence :** A learner belonging to the category of street children/ destitute/migrant's/slum dwellers/orphans not having any residential address at present will have to furnish a self-certificate stating the category (mentioned above) and certify to not have own residential address. However, for the purpose of correspondence with NIOS, such learner will have to furnish a contact address. The self-certificate has to be countersigned by the AA/ NGO / Orphan Home with complete name, designation and address along with their official stamp.
  - (c) **Accredited Agency (AA) wise identification of Pre-Vocational Subjects:** To provide selection of Pre-vocational subjects by the OBE learners the provision for identifying any three Pre-Vocational Subjects at specific Accredited Agency need to be completed, so that learner can choose from the available pre-vocational subjects only offered by Accredited Agency at the time of admission. The AA are directed to update the list of three preferred Pre-Vocational Subjects to be offered by the Accredited Agency to learners. This must be updated through Accredited Agency dashboard by 31st July, 2022.
