

The Schedule for Registration and Payment of Examination Fee for Vocational Courses for May, 2023 is as under:

1.	For all eligible learners (without late fee)	9 <sup>th</sup> March, 2023 to 23 <sup>rd</sup> March, 2023 (without late fee)
2.	For all eligible learners with late fee of Rs. 100/- per Subject/Paper	24 <sup>th</sup> March, 2023 to 28 <sup>th</sup> March, 2023 (with late fee)
3.	For all eligible learners with consolidated late fee of Rs. 1500/- per learners	29 <sup>th</sup> March, 2023 to 2 <sup>nd</sup> April, 2023 (with consolidated late fee)
