The next Public Examination of NIOS for Secondary and Senior Secondary courses is scheduled to be conducted during **October-November 2024**. The schedule for registration and payment of examination fee for Secondary and Senior Secondary courses of this examination is as under:

1.	All learners enrolled in Stream-I, Block-II for Oct 2024 Examinations	7 th June 2024 to 6 th July 2024
2.	All eligible learners for examinations except the learners registered to appear in April 24 Examinations	
WITH LATE FEE OF Rs. 150/- PER SUBJECT		
3.	For all eligible learners as mentioned at Sl. no. 1 and 2 above	7 th July to 16 th July 2024
WITH CONSOLIDATED LATE FEE OF Rs. 1600/- PER LEARNER		
4.	For all eligible learners as mentioned at Sl. No. 1 and 2 above	17 th July to 26 th July 2024
The examination fee payment schedule for the learners registered for April 2024 examinations will be notified after the declaration of result of April 24 examination.		

The learners of Senior Secondary Course must ensure compulsory gap of two years from the block/session and year of passing the Secondary examination for the purpose of obtaining passing certificate. If the learner does not have the requisite gap of two years, he/she shall register only in maximum of four subjects (including the subjects already passed) for the forthcoming Oct 2024 examinations. The learners may therefore carefully select the subject(s) accordingly to appear in the examinations. The requisite examination fee is to be paid only through online mode by visiting NIOS website: <http://sdmis.nios.ac.in>.
