Subject : Recruitment to the post of Academic Officer and Research & Evaluation Officer

NIOS had advertised 17 posts of Academic Officer and 01 post of Research & Evaluation Officer vide Advertisement No. NIOS/RC/01/2021 published in leading newspapers on 11th September, 2021 as well as uploaded on the NIOS website. Due to administrative reasons, the recruitment process for the post of **Academic Officer in Secretarial Practice discipline** was notified in the above said advertisement at Sr. No. 6, stands cancelled. However, the recruitment process for the remaining Academic Officer posts will be continued. The Recruitment fee (only) paid by the applicants to the post of Academic Officer (Secretarial Practice) is being refunded.

2. Further, in terms of provision in the NIOS Recruitment Rules 2007, the Competent Authority has decided to select the candidates for the 16 posts of Academic Officer and 01 post of Research & Evaluation Officer on the basis of written test and interview. Accordingly, the Scheme of examination and Components of Written Test has been prepared and are hereby notified for information of all concerned.

Scheme of Examination for recruitment to the post of Academic Officer and Research & Evaluation Officer on Direct Recruitment basis

- The examination scheme for recruitment to the post of Academic Officer and Research & Evaluation Officer shall consist of :-
 - (1) Written Test (Objective Type) (MCQ)
 - (2) Interview

- The written test will have 180 multiple choice questions for three hours duration and the paper will have three parts.

Part-A

- (i) General Hindi and General English (10 marks each) = 20 marks
(The minimum qualifying marks will be 30% marks separately in Hindi and English)

Part-B

- (i) General Awareness (Bilingual) = 20 marks
(ii) Reasoning & Numerical Aptitude (Bilingual) = 20 marks
(iii) Basic Computer Knowledge = 20 marks

Part-C

- Subject Competency (Post Graduate Level) = 100 marks

Note

1. Answer Script of Part-B and Part-C of a candidate would be evaluated only if the candidate qualifies in Part-A.
2. Merit List will be prepared on the basis of performance in Part-B & Part-C put together.
3. Minimum Qualifying Marks for written test will be 50% for UR, EWS & OBC Category and 45% for SC/ST/PwBD Category.
4. There shall be no negative marking for wrong answers.
5. Candidates will be called for interview in the order of merit of written test in the ratio of 1:5
6. Candidates will be selected on the basis of their performance in written examination and interview put together.
7. Final merit list will be drawn by giving weightage of 80% and 20% to marks obtained by the candidate in written examination and interview respectively.

The Schedule of Written Test for the above-mentioned posts will be informed in due course of time. All the candidates who had applied for the above mentioned posts may kindly note and request to visit NIOS website regularly for any updates for the written test.
