EMPANELMENT OF INQUIRY OFFICERS

National Institute of Open Schooling is in urgent need of the services of retired officers for conducting departmental inquiries. Accordingly, it has been decided to empanel retired officers from Government offices including PSUs for conducting Departmental Inquiries on vigilance matters against the delinquent employees in NIOS. The following eligibility, terms and conditions are to be considered for appointment of willing retired officers as Inquiry Officers:

- (1) Retired Officers (not below the rank of Deputy Secretary) and equivalent officer in the State Governments/Autonomous bodies /PSUs who are willing to serve as Inquiry Officer.
- (2) He/she should not have been penalized in a Disciplinary Proceeding case (No penalty in disciplinary proceeding or prosecution in criminal case)

The panel of the inquiry officers, thus, created for the purpose for conducting departmental inquiry will be valid for a period of three years. The other terms and conditions, including honorarium and other allowances for the empanelment of Inquiry Officers, are as per DOPT vide OM no. F.No.142/40/2015-AVD.1 dated 15th September, 2017.

The eligible retired officers, who are willing to be empanelled as Inquiry Officers, may apply in the format annexed herewith and send their application alongwith brief biodata to CVO, NIOS through email (vigilance@nios.ac.in) or by post at the address i.e. Chief Vigilance Officer, NIOS, A-24/25, Sector 62, Noida, U.P. latest by 25th August, 2022.
